## What did we hear from the community?

89% of respondents want the parklet program to continue with 14% of positive responses suggesting changes.



#### **Enhanced vibrancy**

The spaces are enjoyable, attractive and welcoming, there is a wish to expand use during winter by adding heating and roofs.



#### Parking challenges

Taking away parking spaces is a concern in high turnover parking areas, particularly for patrons with accessibility needs to access shops.



#### Plays to strengths

The extension of outdoor dining aligns with the coastal feel of Bass Coast townships, patrons like sitting outdoors in alfresco dining.



#### CovidSafe spaces

There continues to be a preference to sit outdoors for some patrons.



#### **Business inequality**

Concerns that only a small number of businesses benefit from this program due to reduction in parking.

#### **Road Safety**

Ensuring a continuous line of sight.



#### **Public notice**

Notice of parklet applications

– provide opportunity for
feedback from public



#### Look and feel

Preference for consistency, good design, year-round accessibility for weather.



#### High turnover traffic zones

Look at each application individually for traffic needs
