# Intent to Declare a Special Charge

At the 16 August Council Meeting, Council decided to formally start the special charge scheme for road and drainage upgrade works at Surf Beach and Sunderland Bay estates. Formally starting the declaration process of the special charge scheme does not mean it will go ahead. This process will allow residents to be informed about the costs involved if the project goes ahead, and then ascertain the level of support for the project. Letters outlining the proposed costs and further details about the next steps will be sent to all property owners in the scheme area in approximately 2 weeks time.

Once you receive the above mentioned letter from Council, please consider the information provided and then make your submission and/or objection.
